Rental of the Clubhouse is available to residents for social functions. The clubhouse may not be used for business purposes, fund raising or charitable organization meetings.

- 1. This agreement applies to the Clubhouse meeting room only, and does not include the pool or playground area.
- 2. RENTAL OF FACILITY IS NOT FOR EXCLUSIVE USE ONLY. IF A RESIDENT WANTS TO USE THE GYM, ACCESS CAN <u>NOT</u> BE DENIED VIA ANY DOOR.
- 3. The Clubhouse has a capacity of 35 persons only. Please do not remove furniture from the Clubhouse.
- 4. Children under the age of sixteen (16) years of age and pets (except service animals assisting persons with disabilities) are not permitted to play in the Clubhouse or the exercise room without adult supervision.
- 5. Reservations must be made two weeks in advance of the function.
- 6. All noise and activities cease at 9:00 p.m.
- 7. **Cleanup:** Must be completed prior to Post-Party Inspection and lockup of Clubhouse at 9 pm. All trash accumulated as a result of the event must be bagged and removed from the clubhouse area to the nearest dumpster. (NOT RECYCLING BIN). Failure to clean up will result in a cleaning fee of \$20, and any damages will be assessed, and these deducted from the Security Deposit.
- 8. **Rental Fee** is \$250.00, non-refundable.
- 9. **Security Deposit** is \$500.00, refundable within 10 days after event unless there is damage that takes longer to assess.
- 10. Both the Rental Fee and Security Deposit are required to book. *Please make checks or money orders payable to the Courtyards at Nautica Condominium Assoc.*
